## **PET WAIVER FORM**

At Storii by ITC Hotels we understand that your pet is just as much a part of the family as other members, and are thrilled to be a pet-friendly hotel. In order to ensure that all of our visitors have an enjoyable stay, we request that guests traveling with their four-legged friends sign the policy below upon check-in.



#### Self-declaration by Guest

- My pet weighs 45 Kg or less.
- I understand that only 2 pets are allowed per guest room.
- I confirm that my pet has all required and up to date vaccinations and inoculations and does not have any
  communicable illnesses or diseases. I am hereby submitting proof of all its vaccination. My pet is not aggressive and
  is well-socialized with other animals and guests.
- I agree to properly remove and dispose of any litter or waste associated with my pet on Hotel premises.
- I understand that my pet is not allowed on the furniture.
- I declare my pet is free of fleas, not aggressive & we are carrying muzzles if so be required in case of exigencies.
- My pet will be with me and under my care at all times as they are not to be left unattended on property.
- My pet will be on a leash with a maximum range of six feet or in a carrier at all times when outside of the room and shall never be left unattended at any time.
- I understand that a non-refundable charge of INR 2,000 per pet, per stay (up to 5 nights), will be charged upon check-in for post-departure room cleaning. For stays of 5 to 10 nights, the charge is INR 4,000. I further understand that this fee does not include any additional costs which may result from damage or need for excessive cleaning of soiled linens, carpeting or furniture.
- I am aware that an additional charge will apply if excessive cleaning is necessary. I also agree that the condition of the room is based on the sole judgment of management upon my departure.
- I accept full responsibility for any liability arising from my pet (pet damage or personal injury to hotel, hotel staff, guest, third party or property).
- As a pet owner, I am liable for any disturbances my pet causes to guests staying at the Hotel. I understand that an additional charge may be applied in the event of any disturbances. On the second incident of a reported disturbance, the Hotel may ask for the pet to be removed from property.
- I understand that my pet is not permitted at any indoor F&B outlets, the fitness center or meeting rooms of the Hotel.
- The Hotel is not liable for any injury suffered by pet while on the hotel premises.
- I acknowledge that I have been informed of the pet-friendly policies and procedures of the Hotel. I am aware that I may be responsible for additional fees if damage, excessive noise and/or flea infestation occurs during my stay.

#### Terms & Conditions -

A minimum security deposit of INR 15,000 will be collected in advance and returned upon checkout, provided there are no damages to the property incurred by the pet(s). However, should the damages exceed the security deposit, the pet owner is to bear the entire cost of damage reparation and replacements, even in the situational absence of a formal invoice. These reparation charges are to made entirely prior to guest departure. Security deposits could exceed well over INR 15,000 based upon the management's discretion.

We do not provide any pet crates, mattresses, meals, toys, food bowls, water bowls or sanitary mats. Pet owners are requested to refrain from using hotel furniture, bed and bath linen for their pets. They must carry their own pet supplies. A failure to do so could incur in monetary fines decided by the hotel management.

We attempt to assign more secluded rooms to pet owners in order to avoid disturbing other guests. Kindly comply and adjust with the same.
